The start will be signposted off the A417 Gloucester/Cirencester Rd @Nettleton Bottom The Trial will be open to affiliated members of Zona One M.C.C and will be run in accordance with the National Sporting Code, the standing regulations of the Auto Cycle Union (Ltd), the following supplementary regulations and any final instructions to riders that may be issued on the day of the event. ## **Route / Course options**

**There will be two routes riders changing route will not be eligible for an award**

**Clubman Route** : marked with Red (Right) and Blue (Left) markers (Experts can ride Clubman route)

**Sportsman** route variation marked with pairs of yellow markers when deviating from Clubman Route

**Riders Numbers** two must be displayed at all times. (as per Western Centre guidelines)

**Punch Cards** may be used if no observers so only one number will be issued

**Please Note Breach of Rules NSC 11.01.2** .Any attempt to influence improperly any Official in the course of their duties, ie (**Observers**)

**NSC 11.01.7** Any act which is of a violent, threatening or abusive nature to any Official, Rider or Passenger or any other person. For the purpose of this article, a prejudicial act shall be deemed to include (but not be limited to). the parent or legal guardian of a Rider or Passenger, or any member of his entourage, is deemed to bear mutual responsibility with that Rider or Passenger.

## **Class Options**

Solo Adults of Expert , Intermediate and Novice status. Note – Riders over the age of 40 should state “OVER 40” on their entry form. ( Example “Novice over 40”)

Youths of A; B; C ; and D; class .

**Awards** presented at the end of the Summer series, 2 rounds, all rounds to be ridden to count for awards, points awarded for each class ie 10/9/8/7/6/5/4/3/2/1 totals to be added up at end of series the Awards will be BVM vouchers

**Clubman Route** Expert; Inter; Inter+40; Novice; Novice+40; Twn/shock; P65; Youth A; Youth B; Youth C;

**SportsmanRoute** Inter; Novice; Novice+40; Novice; Twn/shock; P65; Youth A; Youth B; Youth C; Youth D ;
